During FY18 our total **intake for small mammals increased by 61%**. As the only open admission shelter in Larimer County that serves all companion animals, including small mammals we provided second chances to 677 rabbits, rats, guinea pigs, gerbils, hamsters and other small mammals.

FROM OUR *CEO AND BOARD CHAIR*

This fiscal year (July 1, 2017 - June 30, 2018) our continuing quest to make Northern Colorado a great place for animals and people was indelibly imprinted by our move to our state-of-the-art shelter. Over Labor Day weekend we carefully transported 119 animals and got them settled into our new shelter. We officially opened our doors to the public on Tuesday, September 5, 2017. This past year has been a whirlwind, and at the same time, it's remarkable. We feel much more equipped to deliver on our mission to the community; to further the compassionate, safe, and responsible relationship between animals and people.

The new shelter is a welcoming place for pets and humans alike. We have extended the hours of the new intake lobby, which has enabled us to be there for people when they need us the most. This past year, more pet owners turned to us to responsibly re-home their pets when they were no longer able to care for them. We also continue to exceed national averages in reuniting lost animals with their families and finding forever homes for stray animals.

As we've grown into the new space, we are discovering how we can expand our reach to create a positive impact on animals. Not only did we increase our overall animal intake by 6% - welcoming 6,346 animals to the shelter - we also grew our capacity to accept animals through our transfer program. This program provides a second chance to pets in other communities, some in post-disaster situations. For example, in October we transferred in a group of dogs displaced by hurricane Maria in Puerto Rico and helped them to find loving new homes here in Northern Colorado.

Our Animal Protection & Control team keeps pets and people safe in our community. This year, in particular, we assisted the Larimer County Department of Health with

rabies exposure cases and responded to thousands of aggressive animal and bite reports. As an organization, we also collaborated with Fort Collins Cat Rescue & Spay/Neuter Clinic to provide free rabies vaccine clinics. Additionally, we expanded the Humane Education Program in order to teach more children what it means to be responsible pet owners and to respect animals in order to prevent bites. This program helps to provide the foundation for future animal care in our community.

We aren't just experiencing growth in the number of animals and people we are able to help, we are also seeing growth in our community's support of and recognition for our work. Our 2018 Fire Hydrant 5K & Paws on the Promenade Expo realized the largest turn out yet with an increase of 2.5% in revenue over the previous year. We also raised more money than ever through Colorado Gives Day, increasing our philanthropic support to more than \$67,000. In April we were recognized for our commitment to people and ethics as the nonprofit recipient of the 2018 Better Business Bureau Torch Awards for Ethics from the BBB serving Northern Colorado and Wyoming.

With our new space, strategic direction, and programmatic foundation we continue to be there for pets and people when they need us most. None of this would be possible without your support and partnership. Thank you for joining with us as we make Northern Colorado a great place for animals and people.

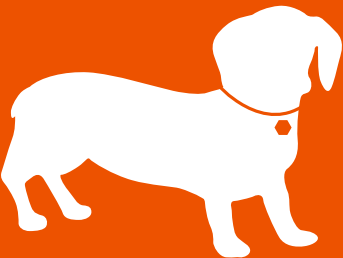

During FY18 our **Veterinary Services team moved into our new state-of-the-art clinic** allowing us to complete diagnostics more quickly and conduct more thorough evaluations thanks to our new onsite x-ray machine. Our larger space also allowed us to expand our partnership with Colorado State University and Front Range Community College to provide hands-on learning for their veterinary medicine and veterinary technician students.

Protecting Public Health
In FY18 our Animal Protection & Control team worked to protect public health for both animals and people by collaborating with the Larimer County Department of Public Health on nearly 2,000 rabies exposure cases.



Saving Lives
During FY18 Animal Protection & Control officers helped save the lives of 317 pets that were left in hot cars. Our average response time for these calls were just 13 minutes.

FOSTER CARE

Animals with special needs need special people. Not every animal that comes to Larimer Humane Society is ready to be adopted. Some need time to grow. Others to recover from sickness or illness. During FY18 our new shelter provided us with a larger and more efficient space to provide humane education programs and expand offerings to include special one-day Critter Camps for school holidays like Martin Luther King Jr. Day, a mascot dog program that allows kids to learn how to safely interact with real-life dogs, and increase our offerings for bite prevention with monthly presentations.

TRANSFER PROGRAM

Because Northern Colorado is such a great place for pets, we are able to look beyond the borders of our county and state to help other communities in need. We transfer animals into our shelter from communities where adoption numbers are low, their quality of life is reduced and the likelihood of euthanasia is increased due to lack of time, space and resources. We are also able to transfer animals from large-scale rescues, or those with special needs, out of our shelter to partners with the appropriate resources to better serve those animals.
