PROGRAMS AND SERVICES


In collaboration with others, expand our service offerings to ensure pets can remain in loving homes, while also striving for excellence in sheltering and animal protection services.

A LETTER FROM OUR CEO & BOARD CHAIR

"Safe at home." Until March 2020, those words seemed so simple. We knew that we wanted to keep our pets safe at home; safe from the dangers of being on their own, of being uncared for, of wandering the streets. For years, you helped us preach the mantra of "safe at home" for the pets in our community, ensuring that animals who became separated from their homes had a safe place to go. Then the novel coronavirus hit and safe at home has taken on so many new meanings for us all.

Choosing Safe at Home as the theme of our annual report to you, our supporters, reflects both worlds. We are excited to share some of the things you made possible during fiscal year 2020 (July 1, 2019, to June 30, 2020) for animals and people to be safe at home.

The year began by celebrating two years in our new facility — a safe, temporary home for homeless and abandoned animals when they are between homes. Soon thereafter, many of you joined us for Larimer Humane Society's 50th anniversary celebration — the Top Cat & Tails Golden Gala, honoring five decades of providing animals with the comforts of safety and home.

During the first half of the fiscal year, your support brought the Better Together campaign to completion with resounding success, raising \$110,000. This support fuels programs helping to keep pets in their homes with families who love them; programs that set our more challenging pets up for success in a new home; and programs that provide pets a temporary, safe home while their families get back on their feet. Several of these new initiatives are highlighted in the pages that follow.

It is impossible to address the second half of FY20 without talking about COVID-19. Thanks to you, responding to emergencies is something we know how to do. From the High Park Fire in 2012, the floods of 2013 — and before and since — Larimer Humane Society has stood ready to help our community's pets and the people who love them amidst crisis.

CHOOSING COURAGE IN THE FACE OF THE UNKNOWN

Life dramatically changed at Larimer Humane Society on March 16, 2020.

Here are just a few of the impacts we experienced due to the novel coronavirus, and how you supported our adjustment.

- You provided critical emergency funds to Larimer Humane Society, helping to cover more than \$5,000 in additional supplies and modifications throughout the building to address employee and client safety, and ensure our work for the animals continued.

- Volunteer support in our shelter was discontinued on March 18, but our volunteer contributions did not stop! From March through June, foster families donated 6,358 hours, providing 173 pets with compassionate care in loving homes.

- From March 16 to June 30, the number of animals cared for dropped by 31% over the same time in 2019 as more families stayed home.

- We temporarily discontinued our educational partnerships with Colorado State University's Veterinary Teaching School and Front Range Community College's Veterinary Technician program as they moved to virtual learning formats for their students. As of the writing of this report, we are developing plans with both institutions to allow hands-on learning for their students with our animals, while ensuring safety for all.

- Healthy Pet Clinics, intended to provide basic veterinary care to underserved areas, were postponed. Modifications are underway to deliver the same quality services in a safe manner.

Strategies FOR SUCCESS



» PROGRAMS AND SERVICES

In collaboration with others, we expanded our service offerings to ensure pets remained in loving homes, and received shelter and protection when they needed it most.

- Your contributions helped launch the Safehouse Safekeep program for clients of Crossroads Safehouse who need temporary housing for their pets. Pets are provided with safe housing and loving care at Larimer Humane Society, at no cost to the owner. In this way, you provide owners escaping domestic violence with piece of mind as they work to build a safer life for themselves and their pets.

- Your generosity allowed for the implementation of a house soiling diversion program for cats, supporting owners who are considering surrendering their cats for house soiling. Through this program, we are testing the cat for underlying medical conditions, and providing assistance to the owner to help them resolve the issue, whether medical or behavioral, to preserve the bond with their cat.

- Thanks to you and our countless dedicated volunteers and staff, the Animal Care department provided twice-daily strolls to our canine residents, totaling 19,939 walks!

- Your involvement provided compassionate, skilled care for 210 cats, dogs and other animals suffering from upper respiratory infection, and 62 animals diagnosed with ringworm. Though challenging to treat in the shelter environment, your commitment allowed our team of experts to provide these animals the best possible outcomes.

- You supported the care of 77 pets in need of housing and loving care through our protective custody efforts, when their owners were unable to care for them due to emergency situations.

- You supported both the Colorado Pet Pantry and Animal Friends Alliance's Kibble Supply Pet Food Pantry with food and supply donations to help owners through difficult times. In FY20, your donations provided 11 clients with emergency food, ensuring that food and supply insecurity did not result in the relinquishment of a pet.

- You provided 301 animals at Larimer Humane Society with extra behavior and enrichment support through the Pets Needing Patience program, setting them up for success in their new homes.

- Your partnership provided low-cost, high volume spay/neuter services to at-risk families across our community through a grant partnership with Animal Friends Alliance. This \$4,000 investment is ensuring that responsible decisions by pet owners are accessible regardless of economic situation.

» OUTREACH AND INFLUENCE

We identified needs and provided resources that were essential to caring for the animals and people in our community.



- Presently, six of our Animal Protection & Control officers are commissioned Bureau of Animal Protection Agents, allowing them to work with local law enforcement to enforce state animal cruelty and dangerous dog statutes. This ability provides additional tools to help keep animals safe. Throughout FY20, our officers handled seven cases of animal cruelty and five cases involving dangerous animals under these state statutes.



- A partnership was formalized with the Town of Windsor to house stray animals at Larimer Humane Society. Officers can bring animals to us day or night as needed for compassionate care, feeding, and housing until pets are reunited with their owners.

- You helped us to launch a new, redesigned website at www.larimerhumane.org. The site is optimized for viewing on mobile devices, an improvement to our previous user experience. Since the launch, we've seen page views and time spent on the site double, along with 780,791 site visits by 313,554 unique visitors.

- Animal Protection & Control responded to a 202% increase in calls for aggressive stray animals over FY19, representing 19% of total calls related to stray animals versus only 6% of stray animal calls in FY19.

- Our participation and support of the Northern Colorado Regional Animal Welfare Coalition continued this year with a slight virtual change after March! We provide administrative support and normally host meetings in the Community Room. Since March we have hosted the meetings virtually. Through your support, coalition members network and share vital resources with each other and receive free learning opportunities.



- In June, your involvement led to a new partnership with the ASPCA Relocation Program. Through careful pairings, the ASPCA matches source and destination shelters, transferring animals from overpopulated communities to places where animals have the best chance at finding a forever family. We are currently paired with Washington County Animal Shelter in Fayetteville, AR, and are thankful for the opportunity to help save hundreds of animals each year.

» ORGANIZATIONAL CAPACITY

We enhanced staff, volunteer, board and financial resources to achieve our goals and support the growth of our organization.

- Your involvement allowed the distribution of a Volunteer Program Assessment, which yielded 172 submissions by participants. We are currently incorporating feedback that was gathered in the survey, with the hope of optimizing the experience of our volunteer program, especially as we begin welcoming volunteers back into our facility.



- A partnership with Elanco has allowed us to provide vaccines to employee's pets, enhancing the benefits we offer our staff.

- In an effort to stretch every donor dollar as far as possible, we have adjusted our lighting and HVAC schedules to improve energy efficiency throughout our facility.

- 264 of you stepped up to our Circle of Champions level by contributing a total of \$250 or more this year! In FY20, 827 total families supported Larimer Humane Society as Circle of Champions members. You ensure that lives are saved, and forever changed, each day.

- 79% of volunteers fulfilled 6 month commitment until mid-March, when regular volunteer shifts were halted due to COVID-19.

- To improve your experience with e-newsletters and emails, we have implemented efforts which optimize the recipient experience. As a result, email opens have doubled and click-throughs have tripled, helping more pets community-wide.

- Your contributions to the 2019 Colorado Gives Day campaign resulted in a 25% funding increase over 2018. That represents over 4,700 days of care for homeless pets!

- You responded very favorably to our new online giving platform and the implementation of Facebook fundraising, which resulted in a 22% online giving increase over FY19.



- You've allowed us to implement quarterly Advocacy Sessions via Zoom, equipping volunteers and other stakeholders with the updates and information to confidently represent our organization.


